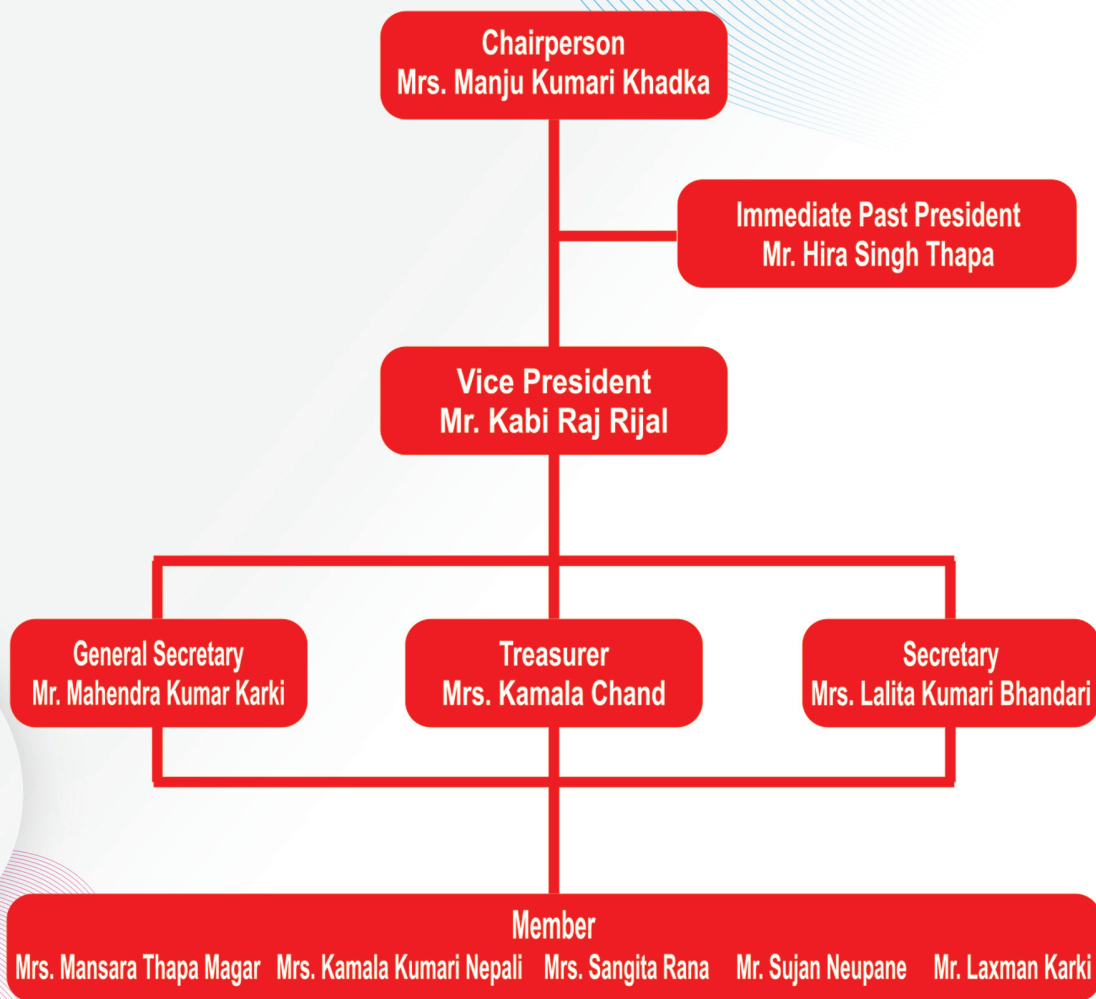

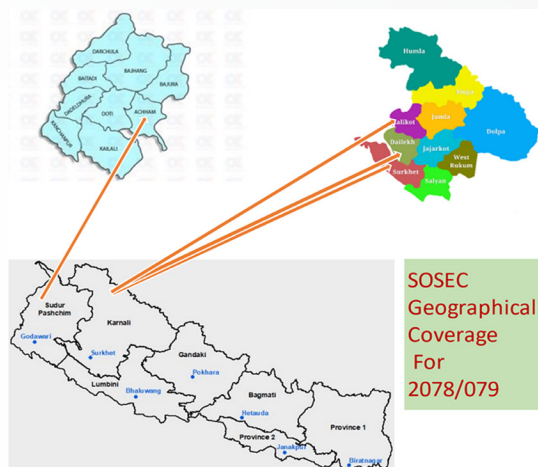

# Brief Intro of Nepal, Karnali Province and Dhaulikh District

Nepal, country of Asia, lying along the southern slopes of the Himalayan mountain ranges. It is a landlocked country located between India to the east, south, and west and the Tibet Autonomous Region of China to the north. Its territory extends roughly 500 miles (800 kilometres) from east to west and 90 to 150 miles from north to south. The capital is Kathmandu. Nepal contains some of the most rugged and difficult mountain terrain in the world. Roughly 75 percent of the country is covered by mountains. From the south to the north, Nepal can be divided into three main physical belts, each of which extends east to west across the country. These are, first, the Terai, a low, flat, fertile land adjacent to the border of India; second, the hilly region and third the mountain. Nepal's HDI value for 2019 is 0.602— which put the country in the medium human development category—positioning it at 142 out of 189 countries and territories.<sup>1</sup>



After the country goes in federal structure, there are seven provinces and seventy-seven districts. Among seven provinces, one is Karnali province which consists 10 districts.

Karnali province borders China to the north, Sudurpaschim province to the west and Gandaki province and Province 5 to the east. The province consists of 54 rural and 25 urban municipalities, and has about 300,000 households. By geographical spread, it is the country's largest province with an area of 30,211 sq. km., covering nearly one-fifth of Nepal's total area. However, it is sparsely populated with over 1.5 million people, accounting for six percent of the national population and the lowest provincial density



in the country (56 persons per sq. km). Despite major improvements over the past few decades, the province lags behind on several development fronts. Some 28.9 percent of its people live below the poverty line with a per capita income of \$606, which is substantially below the national average. The literacy rate is 62 percent (72 percent for males and 53 percent for females).<sup>2</sup> Likewise, 51.2 percent of people are multidimensionally poor; and the Human Development Index (HDI) of the province is just 0.427, both of which are below the national average of 28 percent and 0.49, respectively. The average life expectancy in Karnali is 67 years: the lowest of all provinces.<sup>3</sup>

Malnutrition in children under five years is 58 percent. Furthermore, 35.9 percent of the total population do not have access to safe water, and only 50 percent of the households have proper toilet facilities. There are 439 public health institutions in the province. These represent up six percent and eight percent of Nepal's total, respectively.<sup>4</sup>

By socio-ethnic composition, the province is home to a large share of Brahmins and Chettris (62 percent), followed by Dalits (23 percent), Janajati (13 percent), Tharus (0.5 percent), Madhesis (0.24 percent) and Muslims (0.18 percent). Nepali is the most common language, used by 95 percent of people, followed by the Magar language. Most people in this province are Hindus (95 percent), followed by Buddhists (three percent), Christians (one percent) and others (0.27 percent). The province contributes less than four percent of Nepal's GDP, which is not surprising given the rough terrain and limited number of registered industries (only 39 as of March 2019).<sup>5</sup>

Public administration and defense (11 percent) dominate its contribution to the provincial GDP, followed by education (seven percent), health and social work (seven percent), hotels and restaurants (five percent) and other community, social and personal service activities (five percent). The contribution of other sectors, such as agriculture and forestry, manufacturing and financial intermediation, is meagre at 4 percent, 0.7 percent and 0.9 percent, respectively.<sup>6</sup>

Karnali province has a number of notable tourist attractions, such as the pristine Rara and Shey Phuksundo lakes. The Kankre Bihar ruins in Surkhet resemble the Angkor Wat temples of Cambodia. Other places of cultural significance include Badimalika, Deuti Bajai and Chandannath temples. A number of high mountain peaks, such as Mt. Kanjiroba, Mt. Kanti, Mt. Gorakh, also lie in this province. Karnali province has the potential to become an international trade and tourist conduit to Western China. It has been a fertile ground for publicly funded socio-economic programmes.<sup>7</sup>

In agriculture, the top categories of production include 119,500.54 metric tonnes (MT) of potatoes, 152,577 MT of maize and 160,772 KL of milk. out of total arable land only 31.5% has complete and partial irrigation facility, which is the lowest of all provinces. The region also faces a basic food availability deficit of 16.8 thousand MT. With highly varied physiography, climate and altitude, Karnali province is home to diverse ecosystems. As a result, it has a unique assemblage of flora and fauna, a rich cultural heritage and stunningly beautiful landscapes. The province is expected to harbor a large proportion of Nepal's birds (46%), mammals (42%), butterflies (22%), fishes (32%), reptiles (11%), amphibians (43%) and flowering plants (42%). Many of these flora and fauna are endemic to Nepal and are globally threatened due to human impacts such as habitat loss, fragmentation and climate change.<sup>8</sup>

Dailekh District is located in Karnali Province of mid-western region of Nepal. It borders with Jajarkot to the East, Achham of Seti Zone to the West, Kalikot of Karnali Zone to the North and Surkhet of Bheri Zone to the South. Dailekh has 4 municipalities and 7 rural municipalities. The total area of Dailekh is 1,502 km<sup>2</sup> and composed of 4 municipality and 7 Rural Municipalities, 2 federal electoral and 4 provincial electoral regions. Dailekh lies mostly in the Mid-Hills and partly in the Terai. The lowest elevation point is 544 meter (Tallo Dungeshwor) and the highest elevation point is 4,168 meters (Mahabu Lekh) from

mean sea level. Geographic location of Dailekh is: latitude from 28° 50' N to 29° 12' N and longitude from 81° 30' E to 82° 06' E.

It is said that the name Dailekh is derived from Dadhi Lekh. Dadhi stands for Dadhichi. Dadhichi was a sage in ancient time and Lekh mean hill. Etymologically 'Dadhi Lekh' means the hill where sage Dadhichi meditated. There is also another story about name that, in ancient time it was a place of Devas, so it called "Daibalok" which later became 'Dailekh'.

Dailekh District was a part of Khasa kingdom during 12th to 14th century. Sinja Valley was the ancient capital city and powerful town of the Khasa Kingdom. After the fall down of the Khasa Kingdom it divided into many small kingdoms. Before the unification of modern Nepal, the area of the Karnali region had a United Kingdom named Baise Rajya (Twenty-two principalities). Dailekh principality was one in twenty-two principalities.

with primary focus on overall development of the country acting as helping hand of the government initiatives. Some of the youths of Dailekh having similar aims and perception of developing prosperous society and country, established the organization having inclusive provision of marginalized, Dalit communities, Women, diverse ethnicities in the legal system of the organization. With the main objective to promote human rights, health, education, CCDRR and further development of agriculture sector, organization has been

implementing projects and programs which support to fulfil the actual needs of the community along with focus on skill development rather than mere input supports in coordination and collaboration with different donor and line agencies at Dailekh, Kalikot, Surkhet and Achham districts of Nepal.

The organization is working with poor and vulnerable communities, aimed to address their interest & needs by promoting socio-economic and cultural status. It also encourages the communities for raising their issues themselves along with support in participatory planning as well as prioritization of need-based interventions. For the systematic management, upliftment of its purpose, goals and objectives, 11 board members has been elected from 24th General Assembly in which Dalit Female-1, Janajati Female-1, Others Female-5 and Others Male-4. Similarly, the lifetime members is 146 and ordinary members of the organization is 8 respectively.

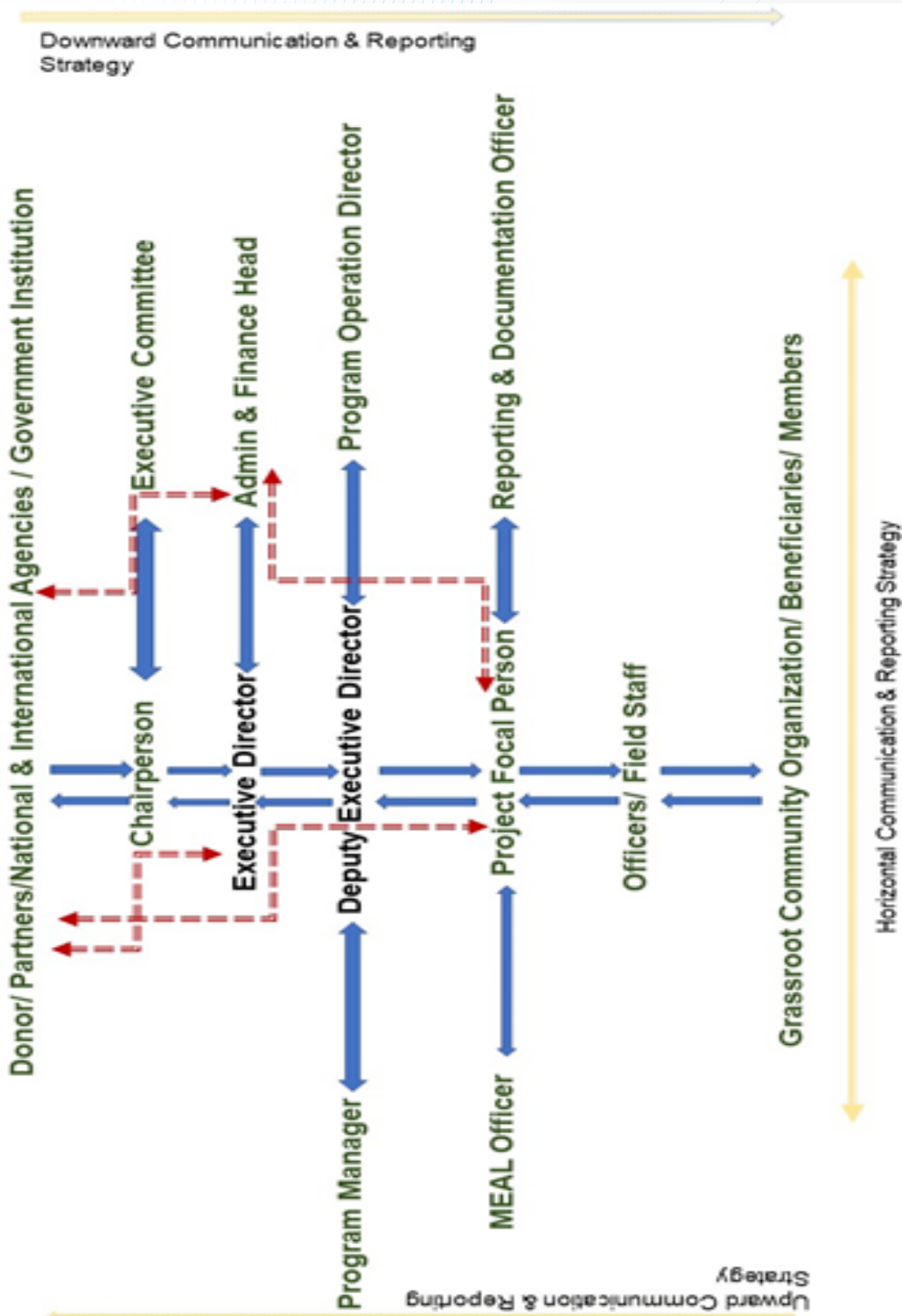

## Part-3

### Key Achievements from Implemented Project

SOSEC Nepal is implementing various projects/programs with collaboration and support of different agencies for the greater improvement in social, economic and cultural status of the back warded people living in the rural communities of different districts, having its own thematic are:

- (a) Livelihood
- (b) Gender (women, children, marginalized communities) and human rights
- (c) Sanitation and physical infrastructure
- (d) DRR and Climate Change Adaptation.

Having main aim about promoting and protecting human rights, health, education and further development of the agriculture sector as per actual needs of the community with giving priority on skill rather than supportive materials joining hands with stakeholders. It is believed that the upliftment of pro-poor through pro-poor as a component of the development is the best and as per this statement SOSEC implementing its programs by mobilizing local resources, local skills and applying its own working approach.

The main objective the organization is promoting human rights, health, education and further development in the development of agriculture sector, which is moving forward for its activities, can fulfill the actual needs of the community that match their objectives and provide priority to the people beyond the object, in concern with the stakeholders who want to enter the community. SOSEC Nepal Dailekh has a special interest in bringing resources to the communities for poverty reduction, ensure of human right, disaster and climate risk reduction and infrastructure development sector, with the consensus of local resources and Skills. This has led the basic mechanism that community should be more alert and responsible for the development of the community, by imminent impression on the people's participation from different channels of interest and has led to the development of the activities of the program to promote the spirit of program perception.

In the fiscal year, 078/79, 81,020 people of 23,379 households have been directly

benefitted through different 12 programs/projects in partnership and coordination with different donor agencies. The project/program wise annual achievement of fiscal year 2078/079 are presented below.

### 3. Project Wise Achievement

#### 3.1 Raute Project

- Project Name: Promotion of health and education rights and improvement in daily lives of Raute people (Raute Project)
- Working Area: Karnali Province (Raute Inhabitant Area)
- Duration of the program: July, 2018 to Dec, 2022
- Funding Agency: AEIN Luxembourg
- Total HHs: 41, Population:144

#### Objective of the program:

Overall Objective: Improvement of the daily living standards of the Raute community through education, health and livelihood

1. Develop Non-formal learning process among Raute community through mobile teaching and behavior change model.
2. Provide support to promote right of health and nutrition of Raute Community.
3. Promote traditional business and create environment for long term residency in a place of the Raute Community.

The thematic area of the project: (1) Education (Non-Formal). (2) Health and Nutrition and (3) Livelihood

#### Major Achievements:

- Distribution of Food items (Rice, Dal, Oil, Salt, Sugar, vegetables) and medicines (First Aid-Kit) to 41 HHs (144 Population) of Raute Community. This Makes their sustenance easy and enhanced in accessing basic health services.



- In 2020 end, population of Raute decreased to 146 from 154. In 2021 end again it decreased to 143. However, at end of 2022 the population increased to 144, which was 0.69% increment than previous. This means the mortality rate is decreased.
- In leadership from SOSEC Nepal, Raute Policy is in the process of development in coordination with Kathmandu University School of





Management and Policy Lab and Karnali province. After formulation of this policy, Raute communities' rights will be ensured and protected.

- Raute community are serious on their personal sanitation and hygiene. Also, they are engaging in community cleanness activities.



- Indigenous knowledge of making wooden utensils from raute community was promoted and support in commercialization. From this their livelihood and identity has enhanced.

- They are slowly adapting modern process of medical treatment, beside adopting old traditional practices.



### 3.2 Integrated Water Resource Management Program (IWRMP)

- Working Area: Dullu Municipality, Dungeshwor and Mahabu Rural Municipality, Dailekh
- Program duration: 1st January 2011 to Continue
- Funding Agency: Helvetas SWISS Inter Cooperation Nepal

#### Objectives of the Program:

- Pro-poor Dalit communities, women and backward communities of Rural Areas have access of pure drinking water and facilities related to Sanitation and hygiene
- Sensitize the local communities to develop Qualitative Drinking water scheme on the basis of actual need of communities and considering the level of practical difficulties.

- Increase awareness in the community regarding safe drinking water and sanitation.
- Motivate for sustainable drinking water scheme and develop feeling of ownership.

### Major Achievements:

- 21 planning management first phase training has been organized. All the planned activity has been conducted along with completion of planning, inventory and logistics management training.



- Eight events of Water safety training were completed at Dullu (2), Mahabu (3) and Dhungeshwor (3).
- Total 76 representative from 5 scheme received project planning management training second phase and established Operation and Maintenance Fund (O&M) for sustainability of project.



- Three days water safety training has been conducted for 40 members of water safety taskforce from eight scheme (Dullu Urban Municipality and Dungeshwor RM). Eight schemes water safety plan was prepared and implemented.
- Dullu municipality has been declared towards total sanitation campaign. Community people were aware on sanitation and hygiene. They are using water filter for pure drinking water.
- Total 21 drinking water scheme along with 10 schools, 1163 drinking water tap was constructed from where about 21000 population have access on safe and clean drinking water.
- Two training on Village Hygiene Education has been conducted at Dullu and Mahabu each one. Their level of awareness and knowledge was enhanced on using safe drinking water, health, sanitation and hygiene.



### 3.3 Women, Youth and Child Rights Promotion (AADHAR) Project

- Working area: Bhairabi Rural Municipality, Dailekh and Palaata Rural Municipality, Kalikot
- Program Duration: 2019 to Continue
- Supporting Agency: AEIN Luxembourg
- Thematic area of project: a) Women, Youth and Child Rights b) livelihood

#### Overall Objective of the Project:

Improve the socio-economic status of women, children and youth in 19 wards of 2 local governments of Dailekh and Kalikot districts.

**Specific Objective:** Women, youth and children are enabled to bring social and economic change in their families and society.

#### Expected Results:

- R. 1. Community people, local stakeholders and government representatives are sensitive to gender and children's issues
- R. 2. Women and youth have access to knowledge and resources for livelihood improvement and acquired skills for sustainable livelihood practices
- R. 3. Reduce and address impact of Covid-19 impact on marginalized

communities

#### Major Achievements:

- 100 Youth & Women of Bhairabi has received Polyhouse and drip irrigation, 7 farmers has received Segregation fan, 9 farmer received she goat, 258 received vegetables seeds for vegetable farming and involved in vegetable farming.



- 84 women were leading various CSOs and committee at LG and community level groups/committee after empowering them through leadership training.
- Distributed learning corner construction materials and established 30 corners for 30 children. Now there is a separate study room for children at school and home.
- 50 HHs (Bhairabi RM 2,3,4 & Palata RM 9) has planted 300 fruits and

- grasses in their land boundary.
- 150 children along with their parents had develop house code of conduct and everyone implement it. After then, 5 parents stopped smoking. Awareness program on COVID 19 was conducted for 450 HHs. Everyone uses mask during out going and mass gathering. They frequently wash their hands with soap and water.
- 110 women and adolescent girls stay in house during menstruation. And 350 used reusable sanitary pads.
- From Advocacy on child marriage and dignified menstruation conducted by Child club, 4 child marriage case (1 in Palata and 3 in Bhairabi) was stopped.
- After sensitized on sanitation and cleanliness by youth and children, 270 washing places and 300 dumping pit were constructed. 2 water source was cleaned.
- Women group were able to collect 2612352 rupees and youth club collects 555697 rupees from monthly savings. This capital has been mobilized as revolving fund for Income Generating Activities.
- Landless Prem BK of Bhairabi got 2.5 ropani land from social mobilizer Krishna BK. After then from the support of Infrastructure development office three room house construction is in process.

- Bhairabi RM allocate Rs 80,000 for children and youth activities. From this, they bought a sports item.



- 116 members form Youth clubs received loan for income generation activities like; goat rearing, poultry, vegetable farming. From the earning they used for children education and familial needs fulfillment.
- 125 people, who earlier went India for working, are now working in their farm at local place.

Specific objective 1: All children, including the most deprived and marginalized, learn from an inclusive and quality basic education.

Specific objective 2: All school-aged children in are safe and protected in and around schools

Specific Objective 3: To eliminate child marriage and early pregnancy in accordance with the 'National Strategy to End Child Marriage in Nepal'

Specific Objective 4: All girls and boys are protected from all forms of physical and psychological abuse in all settings

Specific Objective 5: Local, state and federal governments in Nepal held to account by a strong civil society to meet their obligation to protect children's rights.

## Major Achievements

### Education

- 36 ECCDs are supported with learning materials (Round Table, Carpet, P-Form, Six Learning Corner, Stationary).



- 377 parents after learning about the importance of ECCD education, send their 4 plus years children to ECCD.
- 3 children with disability (Multiple Disability Cases) are enrolled and attending school at home. All are reading in 4<sup>th</sup> grade.
- A girl with hearing disability referred to Red-Cross Secondary School to be enrolled in grade 2.
- 165 girls and 160 boys supported with stationeries, bag, sweater, school dress etc. These children are regular at school. This helps their parents in their children's education continuation.
- 4 (G: 3, B: 1) supported with assistive devices (Walker, Standing Frame, Ankle Foot, Orthosis). This support them for making their school education regular.
- 25 female and 37 male teachers trained to conduct child friendly teaching. Teachers applied the learning from the training into the classroom. 67 teachers



prepared learning materials into their classroom.

- 192 girls and 187 boys benefitted with table and book rack support for child friendly sitting and child-oriented learning.
- Curriculum based Continuous assessment to students of grade 1 to 3 conducted.
- Established students audit system in 47 schools and distributed follow up card and parents are rewarded based on the attendance.



- 286 girls and 270 boys are studying in remedial classes. Now their learning has been enhanced.
- 604 school stakeholders participated in QLE orientation conducted.
- ECCD building constructed - 2, ECCD renovation – 4, Drinking water facility – 6, Classroom renovation – 18, Toilet construction – 5 and total 807(G: 384, B: 423) benefitted from the constructed and renovated activities.

- Educational exposure visits from in and out of the district have to observe and study the best practices of quality education and management.
- Coaching and mentoring support to 104 teachers. This enhanced teaching-learning system among teachers, students and parents.

## Child Protection

- 40 children and 37 adult received Choices, Voices and Promises Sessions. As a result behavior changed in social and cultural norms and values, discrimination against sons and daughters is reduced.



- Ward child fund supported with RS. 30,000 on each 8 wards with total being NRS. 240000. Total 48 children got supported as per the necessity.
- A total of 181 children (G: 99, B: 82) participated in the Comprehensive sexuality education. After this, their level of understanding on sexual

education, reproductive health, child marriage issue has been increased. They are open to discuss on sex related issues with family, teachers and friends.



- Adolescent Friendly Information Center (AFIC) established in 4 Schools. From this there is easy access in communication information regarding adolescent sexual issues.
- 99 adolescent girls and women received my first baby training and learned about warning signs, preparation for birth and emotional stress management during pregnancy.
- 186 people participated in Dialogue among children, local civil society and Palika officials to reduce violence against children. After this stakeholders are empowered on reducing child abuse and violence.
- 183 SMC, parents, teachers and child club members received training about

child participation in local level local level policy formulation process.

- 2 children got rescued from child labor and provided relief materials and rehabilitated.
- Total 108 participants (78 children and 30 adults) received parenting without violence (PWV) training. From this violence case was decreased and they are capacitate on self defense mechanism.
- After organizing program related campaign for anti-child marriage, child marriage case was reduced from 52% in 2019 to 15.90% in 2021.
- Total 137 children and their 68 female parents received violence against Children (VAC) training. After the training they are sensitized on the VAC and cases was reduced.

## Child Rights Governance

- 40 out of 51 indicators of Child Friendly Local Governance (CFLG) are met and Ward 3 and 8 are in the process of Child Friendly Local Governance Declaration.
- Child Assembly organized in 8 wards and Palika where 166 children participated. On the Palika level child assembly, the children handed over the 20 child related plans to the chairperson of Palika.
- Gurans RM, Ward no. 8 has allocated



RS. 30,000 for CFLG, RS, 30,000 for Children's Day and 75,000 for CIJ support. Ward no. 4 has allocated RS 50,000 for CIJ support. 40 CIJ children got supported with NRS 15000 from palika and NRS 10000 from the project. Palika has allocated 13.45% budget for children



- Formation of total 36 school level, 8 ward level and 7 community level child clubs. Total 1316 (G: 728, B: 588) children including 21 children with disability and 2 from gender and sexual minority children are members of child clubs and continuously advocating children rights and participating in extracurricular activities on them on initiation. And 13 children with disability are in the executive position of child clubs.
- 197 children had their birth registered with the free counselling support from the project.

- Learning by Doing and earning approach is practiced under education through operation of agriculture learning center.
- Climate friendly tools and technologies (Solar lift irrigation, poly house, shed improvement, bio-Pesticide, Irrigation Pond, Bio-engineering, drip irrigation, mulching etc) are used for agriculture.
- Climate friendly agriculture system is practices, resulting in reduction of climate induced disaster and its impact.
- Strengthening of value chain model for supporting in agriculture production and marketing.
- Established six learning corner.
- One house, one drinking water tap endorsed under safe and clean water access.
- Transparency (Public hearing, hoarding board, Presentation of annual progress

and planning), Social Audit, Joint Monitoring, Inter sectoral meeting, Participatory Plan, Innovative plan implementation.

- Annually external Audit, physical inspection and monitoring.
- Tax, Tax exemption certificate, Renew, PAN, Registration in Inland Revenue Office
- Regular Annual General Assembly.
- Annual book publication with annual audit report and distribution.
- Coordination meeting with Municipality, Rural Municipality, Local level and representatives of other organizations.

### 5.2 Lesson Learned

- Program implemented as per the needs of community and from their leadership, its effectiveness and sustainable is high.
- Practicing and adopting tools of transparency makes program performance easy.
- Program planning on basis of community seasonal calendar is very fruitful.
- Coordination and collaboration with

all stakeholders from designing phase results in effective program implementation and increase ownership.

- Emphasis should be given to production by focusing on marketing by making value chain actors effectively.
- Programs such as seminars and interaction session should be held between the project, organization and rural municipality to improve relations and better work efficiency.
- Proper guidelines and orientations to the radio program should also be conducted by any means possible in order to ensure and achieve the effectiveness of the program among children and their meaningful participation for school level activities.
- While doing programs through radio and other online platforms, documentation plans and monitoring plans along with their frequency and starting date and time should also be shared in advance.
- If a code of conduct is formulated at home to reduce child violence and abuse, both the children and the parents will follow it with their responsibility.
- Coordinating with team and sub projects resulted best way to reduce the vulnerability caused by the climate change.
- Community and local government are the major responsible for negotiating any project but to implement the activities, need to coordinate with each and every stakeholder related to project.
- Coordination with the local level and the need assessment of the community can help us to set the goals and objectives of the project.
- Public hearing and monitoring of each installment has increased the credibility of the community towards the project.
- Community action plan formulation of project has helped guide the project implementation.
- It has become easy to identify the problems closely working with the service recipients and to facilitate them with suitable solutions can only be effective by analyzing the problems of the women.
- Distribution of posters to the farmers about modern cultivation practices of tomato, cauliflower, cabbage, and potato. Farmers were able to know about the cultivation practices, insects, pest diseases and their control measures
